The Commission issued election notification for conduct of ordinary elections to Municipalities and Municipal Corporations vide Notification No.3038/TSEC-ULBs/2019, dated 07.01.2020, the Commission issued notification for conduct of casual vacancy to the post of Member, Ward 30, Dabeerpura in Circle – 6 of Greater Hyderabad Municipal Corporation vide Notification No.2745/TSEC-ULBs/2019, dated 07.01.2020 and the poll is scheduled on **22.01.2020**. The Commission issued election notification for conduct of ordinary election to Karimnagar Municipal Corporation vide Notification No.3038/TSEC-ULBs/2019, dated 09.01.2020 and the poll is scheduled on **24.01.2020**.

The government has issued General Orders vide G.O.Ms.No.126, MA&UD (C1) Dept., dated:04.05.2016 authorizing the District Collectors to declare local holidays in the areas notified for election and other related issues whenever Election Notification is issued by the SEC and the Commissioner of Labour, Telangana State is directed to declare day of poll as paid holiday to shops and establishments located in the areas notified for elections under Telangana Shops Establishments Act, 1988 declaring the day of poll as a paid holiday to all the employees and workers employed in shops and establishments situated in the areas notified for elections.

In case of employees who are ordinarily reside in the Municipal area where poll is on 22.01.2020 or 24.01.2020, as the case may be, but having the place of work outside the Municipal area, those electors including casual workers working outside the Municipal areas concerned, the State Election Commission appeals all the Managements of Public Undertakings/Firms/Commercial/Industrial concerns located outside the Municipal area to grant their employees, who have vote in the municipal area, to have three hours off, during the poll hours on polling days so as to enable them to exercise their franchise.
