# The Uttarakhand Factories (Amendment) Rules, 2019

Short title and Commencement

1. (1) These Rules may be called the Uttarakhand Factories (Amendment) Rules. 2019.

Amendment of Rule 7

- (d) Where the number of workers exceeds 250-one seat for every 50 or fraction of 50.
