Contract Labour (Regulation and Abolition) Act, 1970 No: GHR/2020/163 /CLA/152020/415126 /M (3):- WHEREAS certain draft rules were published as required by sub-section (1) of section 35 of the Contract Labour (Regulation and Abolition) Act, 1970. (37 of 1970), at pages 232-1 to 232-1, in the Gujarat Government Gazette, Extra Ordinary, Part IV-A, dated the 2nd December,2020, under the Government Notification, Labour and Employment Department No: GHR/2020/152/CLA/152020/415126 /M (3), dated the 26th November, 2020, inviting objections and suggestions from all persons likely to be affected thereby within a period of thirty days from the date of publication of the said notification in the Official Gazette;

AND WHEREAS the objections or suggestions have been received by the Government in respect of the said draft notification;

NOW, THEREFORE, in exercises of the powers conferred by section 35 of Contract Labour (Regulation and Abolition) Act, 1970. (37 of 1970), the Government of Gujarat hereby makes the following rules further to amend the Contract Labour (Regulation and Abolition) (Gujarat) Rules, 1972, namely:-

- (1) These rules may be called the Contract Labour (Regulation and Abolition) (Gujarat) (Amendment) Rules, 2020.
 - (2) They shall come into force on the date of their publication in the *Official Gazette*.
- In the Contract Labour (Regulation and Abolition) (Gujarat) Rules, 1972 (hereinafter referred to as the said rules), in rule 24, for the letter and figure "Rs. 270" the letter and figure "Rs. 540 "shall be substituted.
- 3. In the said rules, for rule 26, the following rule shall be substituted, namely:-
 - 26. Fees: (1) The fees to be paid for the grant of certificate of registration under section 7 shall be as specified below, namely:-

If the number of workmen proposed to be employed on contract on any day,-

(a) 50 or more, but not exceed 100.

Rs. 1800/-

(b) exceeds 100 but does not exceed 200.

Rs. 4800/-

(c) exceeds 200 but does not exceed 400.

Rs. 7200/-

(d) exceeds 400 but does not exceed 800.

Rs. 9000/-

(e) exceeds 800.

Rs. 12000/-

(2) The fees to be paid for the grant of a license under section 12 shall be as specified below, namely:-
